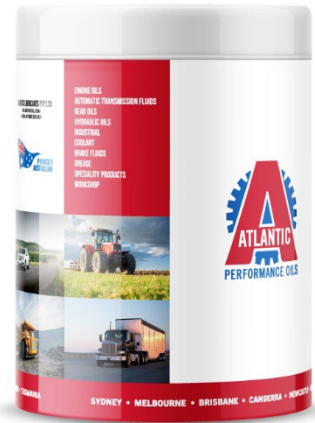
Product Description:
